- 1.2 In terms of clause 8.2 the trustees shall have all the powers that are required or allowed in law and in particular the powers of assumption and co-option; and clause 8.3 requires such assumption to be in writing.

- 2.3 the new trustee shall enjoy all the powers, duties and obligations imposed in the trust deed.
